Objectives of the Awards

To create a platform, recognize and showcase the initiatives and services provided by organizations and individuals which has created a platform to promote India as a premier medical travel destination.

In its fifth edition, the FICCI MVT Awards will continue aiming at honoring the efforts and dedication of members of the industry who are doing inspirational work. FICCI Medical Value Travel Awards 2024 will be held on 18th December 2024 at India Expo Centre & Mart, Greater Noida (NCR).

ELIGIBILITY CRITERIA

- Any organization/ institute/ participating / centre in the Awards should be an Indian entity with at least 2 years of registered presence and operations in India as on June 30, 2024
- Any organization/ institute participating in the Awards should be NABH/Internationally (JCI or ISQUA certified) Accredited/any other international accreditations
- The project/initiative/innovation/service should be completely executed in the Indian operations of the participating institute
- The project/ initiative/ innovation/service should have been implemented or in operation in the period July 01, 2022, to June 30, 2024 (or major part of the initiative should fall into the defined period), with impact demonstrated and results showcased by initiative/ project in the period July 01, 2023 to June 30, 2024

- Participating organization / institute must be engaged in providing healthcare services relevant to the category selected to the patients who are travelling from other countries to India for medical treatments
- Entities which are a part of a group of hospitals must apply as an individual unit for all initiatives undertaken for the Awards
- Employees and immediate family members of the award management, sponsors and partners of the awards are not allowed to participate in the Awards
- Participation in the awards is subject to defined rules & regulations available on website https://ahcindia.ficci.in/

APPLICATION PROCESS

- Forms should be filled in English only
- All mandatory questions (symbolised by *) must be answered. Incomplete forms
 or forms with incomplete sections may not be considered
- Please maintain one copy of the completed form with you for your records
- Please provide up to 5 supporting documents wherever possible, to support your entry details. Supporting documents must be in the following formats only - pdf, doc, jpeg etc. Size of each document cannot exceed 2 MB
- Agreed Declaration by the Authorised person of the institute is mandatory

SELECTION PROCESS

- All valid entries will be screened by an interim jury panel.
- The jury will have the sole right and discretion to reject entries that in their view do not meet the basic specified criteria.
- Based on the evaluation framework agreed with the Jury, screening Jury will scrutinise all valid applications received and short-list entries for field visit verification.
- Field visits to the finalists will be conducted by an independent agency nominated by FICCI to validate the authenticity of the information provided in application form/questionnaire.
- Post field visits, finalists will be evaluated by the Final Jury. Final jury will comprise of eminent persons from MVT, healthcare and related fields, for determination of winners.

- There could be one or more winners in each award category, as mentioned in the category section. However, the final decision will be at the discretion of the Jury.
- Jury's decision on all matters relating to these Awards would be final and binding on all participants, and noncontestable. In case, the Jury does not come to a consensus on a particular category, the Jury may not award that category and proceed as it otherwise deems suitable.
- For the Final Jury round, finalists will be invited in person to interact with the Grand Jury Members.
